

Institutional Travel Warning Form

This *Institutional Travel Warning Form* must be signed by an authorized official from the home institution of the Boren Scholar proposing to study in a country under a U.S. Department of State Travel Warning. By signing below, the official certifies the following:

1. On behalf of *Home Institution*, I certify that I am a duly authorized officer of *Home Institution* with the power and authority to affirm the understandings and provide the certifications set forth in this document on behalf of *Home Institution*.
2. *Home Institution* understands that *Scholarship Recipient*, a student at *Home Institution*, has been awarded a Boren Scholarship under the National Security Education Program (NSEP) to study in *Study Abroad Country*.
3. *Home Institution* understands that the U.S. Department of State has issued a Travel Warning for *Study Abroad Country*, which may advise against travel to *Study Abroad Country* by United States citizens.
4. *Home Institution* understands that Boren Scholarships for students to study in a country under a U.S. Department of State Travel Warning are contingent upon the appropriate responsible official at the home institution certifying that the institution has a formal policy regarding U.S. Department of State Travel Warnings; that the institution is aware of the Travel Warning; that the institution has reviewed the safety situation in the country, by consulting the Travel Warning along with other sources; and that the institution has determined, subject to its policy, that study in that country is acceptable for its students.
5. *Home Institution* understands that the Institute of International Education (IIE), as the administrating agency for NSEP, is, for the purposes of the Boren Scholarships, solely a scholarship funding source, and is not responsible for the selection of the study abroad location or the safety and security situation therein. IIE will not be responsible for the monitoring of the safety situation in *Study Abroad Country* during the time the student will receive the scholarship, and will not be responsible for evacuating or relocating the student because of safety concerns and/or any other reason.
6. *Home Institution* understands that while the student is abroad, *Home Institution* is responsible for ensuring that appropriate student services, including orientation, health and safety information, and emergency support services, are provided for the student either by *Home Institution* or the study abroad provider.
7. *Home Institution* has a formal policy regarding U.S. Department of State Travel Warnings, a copy of that policy is attached to this document, and as of the date of this certification, no amendment or modification has been made to such policy.
8. Under the terms of the policy referenced above, *Home Institution* has consulted the U.S. Department of State Travel Warning for *Study Abroad Country* and has determined that *Home Institution* students may study in *Study Abroad Country*.
9. It is the intent of the *Home Institution* that *Scholarship Recipient* will remain fully enrolled in a credit bearing program as a matriculated undergraduate student at *Home Institution* during the time that the student is in *Study Abroad Country* with support from a Boren Scholarship.
